Terms and Conditions of ATIS Research

The following are the terms and conditions pertaining to research requests for committee materials, including standards and contributions, of the Alliance for Telecommunications Industry Solutions (ATIS).

1. All requests for ATIS research must be made in writing using the *Request for ATIS Research* form. All relevant information must be provided. ATIS reserves the right to refuse to undertake research that is overly broad or would otherwise interfere with the performance of ATIS' core activities.
2. ATIS can only provide electronic access or electronic copies of the materials in some cases. ATIS has the right to decide in which cases electronic copies are allowed.
3. ATIS will undertake reasonable steps to locate requested materials, but cannot guarantee that the requested materials will be available.
4. ATIS cannot guarantee the completion of research by a specific date. The scheduling of research will depend on the availability of ATIS staff and other resources.
5. If space and staff resources are available, ATIS will permit the on-site review of materials. Requestors may not remove original documents from ATIS. All documents must be carefully handled and may not be paper clipped, dog-eared, or marked. The documents must remain in the same order within the box/binder/folder as originally provided by ATIS. On-site inspections must be scheduled in advance by ATIS based on the availability of ATIS staff and must take place during normal ATIS business hours.
6. Customers will be assessed fees for access to ATIS materials. These fees include research, copying/scanning, shipping and handling, and are currently set at:

Research:	\$75 per hour
Historical Document:	15% processing fee added to the base price of document
Copying/Scanning:	\$0.13 per page
Handling:	25% of shipping charges
Delivery:	All documents will be delivered electronically (free of charge) unless hard copy delivery is requested (customer would pay all hard copy shipping fees)
