Re: Notice of Ex Parte, CG Docket No. 16-145

Dear Ms. Dortch:

On September 13, 2016, representatives from the Alliance for Telecommunications Industry Solutions (ATIS), CTIA and the National Emergency Number Association (NENA) met in person and via telephone with representatives of the Commission's Office of Strategic Planning & Policy Analysis (OSP), Public Safety & Homeland Security Bureau (PSHSB), and Consumer and Governmental Affairs Bureau (CGB). The purpose of the meeting was to discuss issues related to Real-Time Text (RTT) raised by the Commission's *Notice of Proposed Rulemaking* (NPRM) released May 25, 2016, in the above-referenced docket.

During the meeting, the parties discussed issues raised in the docket, including the technical issues related to RTT-TTY backwards compatibility, the potential for existing network capabilities that support Text-to-911 to also support RTT-originated 9-1-1 communications with Public Safety Answering Points (PSAPs), and on-going discussions among stakeholders, including representatives from the disability rights community, about the default settings for RTT operations on a wireless handset in the development of ATIS standards. In addition to the points raised by ATIS below, the parties generally expressed a desire to engage the appropriate technical representatives within the parties' respective organizations to consider these issues.

Specifically, as noted in its comments, ATIS cautioned the FCC against any requirement for backwards compatibility of TTY and RTT devices in support of non-emergency calling due to a significant concern related to transcoder overloading and resulting potential for denial of service to RTT users of E9-1-1 and TRS 711 services. Representatives from ATIS explained that, when RTT-enabled phones are configured to accommodate all incoming calls from the circuit switched network as TTY calls, the network must reserve an RTT to TTY transcoder in case it may be needed for the call (i.e., a party activates an RTT session); otherwise, a transcoder may not be assigned and calls that begin as voice calls will not be able to transition to an RTT session. However, if an RTT call is initiated as RTT, ATIS noted that the transcoder overloading issue is less of a problem as normal traffic engineering practices can be applied. Therefore, ATIS representatives suggested that the Commission's proposed backwards compatibility requirements in the *NPRM* could have a significant impact on the industry and could require the industry to upgrade all transcoders to support RTT, or to develop more specific transcoding resourcing with the ability to assign instantaneously.

NENA representatives reiterated the importance of deploying RTT quickly and in a standardscompliant manner. Moreover, they explained the importance of considering PSAP operations impacts of the RTT transition, and providing PSAPs with implementation flexibility.
