7. Liaison Reports

7.1 Committee T1/T1AG

The Chair provided a report of the February 2001 Committee T1/T1 Advisory Group meeting in San Antonio, TX.

He reiterated that the election of Mr. Townsend to Vice Chair occurred at this meeting.

The Chair also reported that the new Chief Editor for Committee T1, Chad Underkoffler, attended the San Antonio meeting. Mr. Underkoffler presented some templates that he has been working on in an effort to streamline the editing process of all TSC documents. He is putting together a guide to assist the TSC technical editors, so that their focus can be on the content of their documents, and not on the word processing procedures.

The Wireless LAN was also discussed during the T1/T1AG meetings. Other TSC's have also been experimenting with the use of the Wireless LAN. T1P1, for example, has had great success during their meetings. The Chair expressed his hope for the possibility in the future of obtaining high-speed web access through the LAN. The Chair added that the flashcards and wired LAN would still be in use at future meetings as needed.

Virtual Meetings are being offered to the TSCs via the Secretariat, and the Chair encouraged the use of these meeting methods for any interim meetings. He encouraged T1E1 members to contact Charnita Williams, at ATIS, to set up a virtual meeting (cwilliams@atis.com).

Finally, the Chair explained that there would be a disclaimer contained in all electronically published documents which contain color, helping to clarify what should be seen when documents are downloaded or printed.

8. Report of Working Group Chairs and Approval of Requested Action Items
