HUGHES NETWORK SYSTEMS STATEMENT OF GENERAL LICENSING POLICY

Hughes Network Systems (HNS), a unit of Hughes Electronics
Corporation, is a global leader in satellite, digital cellular and enterprise
networking technologies. As such, HNS' intellectual property is one of its most
valuable assets.

Factors considered by HNS which may affect the terms and conditions offered to a prospective licensee of HNS' intellectual property include the breadth of the intellectual property sought to be licensed, the territorial scope of the prospective license, the term of the prospective license, the presence or absence of alternative technologies, the cost and price of products embodying the licensed technology, the nature of the license (e.g., exclusive or non-exclusive), and whether intellectual property is offered for cross-license by the prospective licensee. Of course, other factors may also influence the terms of any particular license.

Given due consideration to the above factors, with respect to any essential patents held or controlled by HNS, pending or anticipated to be filed necessary to implement the Personal Communications Services Common Air Interface Standards, HNS agrees that a license will be made available to applicants under reasonable terms and conditions that are demonstrably free of any unfair discrimination.
