Re: Sunset of 800-855 Number Assignment Guidelines (ATIS-0300047)

Dear Ms. Monteith and Mr. Webre:

The Alliance for Telecommunications Industry Solutions (ATIS) Industry Numbering Committee (INC) is writing to inform you of INC's decision to sunset the 800-855 Number Assignment Guidelines (ATIS-0300047), which were created in 1994 to provide guidance to the NANPA and applicants regarding the assignment of the 800-855 numbers for services for the deaf, hard of hearing or speech impaired.

In 2008, the Federal Communications Commission (Commission) ordered the adoption of a uniform Ten-Digit Telephone Numbering System for Internet-based TRS (iTRS) ¹, making the assignment of these resources no longer necessary. In 2011, the Commission issued another *Report and Order* requiring persons holding toll free numbers to request that the numbers be linked to a 10-digit telephone number in the iTRS Directory. ² At that time, the Toll Free Number Administrator (TFNA) notified all Responsible Organizations (RespOrgs) of the 2011 *Report and Order* and the required transitions.

While no new assignments have been made for some time, the 800-855 Number Assignment Guidelines were never formally sunset. INC notes that the NANPA had assigned a total of ninety-three (93) 800-855 line numbers since the creation of the guidelines, but none in the last seven years. Additionally, INC has confirmed with the iTRS Administrator that the ninety-three (93) 800-855 numbers are not provisioned in the iTRS Directory.

INC has agreed to formally sunset the 800-855 Number Assignment Guidelines. In addition, NANPA will submit a Change Order to remove the application function for the 800-855 line numbers. Upon approval of the Change Order, NANPA will update its website to reflect the sunset of the resource. The NANPA will also publish a Planning Letter announcing the sunset of the 800-855 Number Assignment Guidelines and provide industry notification that these line numbers are strictly assigned for toll free use and no longer are assigned by NANPA.
